✓ Low Severity Issues

1. Out of gas

Issue:

- The function `airdrop()` uses the loop to transfer airdrop amounts.

Recommendation:

Check that the excluded array length is not too big.

2. Airdrop arrays conformity

Issue:

- The function `airdrop()` do not check length of `airdropAddresses` to be equal to `amounts` array length.

Recommendation:

Check that the arrays have equal length.

Owner privileges (In the period when the owner is not renounced)

- Owner can change liquidity fee.
- Owner can change the maximum transaction amount.
- Owner can change dev address.
- Owner can call airdrop.
- Owner can withdraw tokens.
- Owner can withdraw ETHs.
- Owner can enable and disable tax for addresses.

Conclusion

Smart contracts contain low severity issues! Liquidity pair contract's security is not checked due to out of scope. Audited only this contract. The further transfers and operations with the funds raise are not related to this particular contract.

Liquidity locking details NOT provided by the team.
